B. Updated Commentary

1. Further to KQU 3677 of 29.11.25, **being an Important matter**, we would inform you about Article of Muhammad Bilal [Pakistan Imported Mobile Phones Worth Rs. 226 Billion in First 5 Months of FY26](#) (**Attachment 425.1**) in the ensuing paragraph, with emphasis in **bold & Underline** for quick reading in detail area.
2. **Pakistan's mobile phone imports surged to \$801.139 million during the first five months of the current fiscal year, FY26, recording a growth of over 40 percent compared to the same period last year, according to official data.**
3. **During July to November FY26, mobile phone imports increased from \$570.184 million last year to \$801.139 million. In rupee terms, the value of imports rose to Rs. 226.133 billion, compared to Rs. 158.518 billion in the corresponding period, showing a growth of 42.65 percent.**
4. On a month-on-month basis, mobile phone imports increased by 8.30 percent in November 2025 to \$156.565 million, compared to \$144.563 million in October. However, on a year-on-year basis, imports in November declined by 4.81 percent compared to \$149.378 million in November 2024.
5. Despite the recent rise, mobile phone imports had declined in the previous fiscal year. Pakistan imported mobile phones worth \$1.494 billion in FY25, down 21.31 percent from \$1.898 billion in FY24.
6. In rupee terms, mobile phone imports stood at Rs. 417.351 billion in FY25, reflecting a decline of 22.09 percent compared to Rs. 535.690 billion in FY24.
7. Overall telecom imports during FY25 were recorded at \$2.099 billion, showing a negative growth of 11.30 percent compared to \$2.366 billion in the previous year.
8. **Meanwhile, local mobile manufacturing and assembling continued to show strong performance. During the first ten months of calendar year 2025, local plants manufactured or assembled 25.11 million mobile handsets, compared to only 1.7 million imported commercially.**
9. In October 2025 alone, 2.33 million mobile phones were locally manufactured or assembled, while only 0.2 million handsets were imported.
10. The locally produced handsets included 13.2 million smartphones and 11.9 million 2G phones. According to Pakistan Telecommunication Authority data, around 70 percent of mobile devices currently active on the network are smartphones, while 30 percent are 2G phones.

B. Updated Commentary

1. Further to the KQU 3637 of 6.11.25, **being an important matter**, we would inform you about How children, etc can be kept away from Mobile extra use or misuse to possible extent? (**Attachment 69.1**).

2. The speaker highlighted that everyone seeks ease and enjoyment, including children who find it in mobile phones due to the instant gratification and lack of effort required. He contrasts this with parents who often nag about studies, inadvertently making themselves less appealing compared to the readily available entertainment on devices.

3. The speaker suggested becoming an interesting person to your child by involving them in your activities like cooking or reading. He humorously advises mothers to become like the 'hen' of the house, so their children ('chicks') will follow them instead of being glued to their phones.

4. The speaker emphasized that it's crucial for mothers to introspectively question why their children might not want to spend time with them, rather than resorting to blame. He suggests that mothers should seek solutions by identifying what they might be doing wrong.

5. He also emphasized the importance of parents becoming more engaging in their children's lives, suggesting that children turn to mobile devices out of boredom. They advise parents to identify and nurture their child's strengths and hobbies as alternatives to screen time.

6. The speakers emphasize the importance of engaging children in activities like art, crafts, and scientific experiments to reduce their screen time. They also stress that parents should model responsible mobile phone usage, limiting their own scrolling to set a positive example for their children.

7. The speakers emphasize the importance of engaging with children lovingly and intelligently, rather than resorting to anger or rudeness. They advocate for a balanced approach—being polite yet firm—to effectively communicate expectations and maintain authority without alienating children.

B. Kasbati & Co Views - Urgent Actions

1. Due to Internet availability in Offices, Over usage of **so called Smart Mobile (making it unsmart)** is affecting Productivity of the Employees in almost all the Departments. Hence, the All the Department can take measures to control the same.

2. Owing to availability of Internet at Home too, there is generally mobile usage for several hours, especially at night; affecting sleep, which Leads Late awakening and Office / Business Efficiency too. Hence, there can be surveys as to Mobile usage and Sleeping time Survey too.

3. There is also creating distances between Family members and needs to be controlled ASAP.

4. In several Counties to it is banned till a certain small age and few countries are considering banning it for higher ages too.

5. Our Survey at different Workshops and Classes revealed unnecessary Smart Mobile usage ranging 3 to 4 hours and even Professionals were hardly willing to reduce it to even 1 hour in one months time (with their growth plan given to them) and let us hope for the best.

6. As Parents, we can also plan to reduce its unnecessary usage to 15-30 minutes in a short span of time.
