2. The Ministry of National Food Security & Research has issued its **Annual Procurement Plan for FY 2026-27** under Rules 8 and 9 of the Public Procurement Rules, 2004. The plan covers routine procurements as well as major projects, including **Rs 35 billion for procurement, storage and handling of wheat under the National Wheat Strategic Reserves Programme** and **Rs 120 million for third-party monitoring and validation services**. These major procurements are subject to ECC approval.
